Between the various affiliates, approximately 20 seminars, conferences, and pre-conference events are conducted each year, with hundreds of combined participants, who apply what they have learned to train other individuals going into the missions field.

The various affiliate organizations conduct their own Community Health Evangelism and Neighborhood Transformation programs. Highlights of these programs include a number of programs within the Phoenix Metropolitan Area conducted by Arizona Neighborhood Transformation and its local partners; an extensive outreach to the poor and displaced in urban communities conducted by Salvaged Lives; church planting and continued CHE operation in the city of Zihuatanejo, Mexico, which is carried out by the Global CHE Network; and a similar church planting and evangelism program in central Europe, conducted by CHE Central Europe.
