"Global Community Health Evangelism Network" carries out the training of church and missions leaders in the practices of Community Health Evangelism (CHE), which is designed to combine Jesus' commandments to heal the sick and make disciples of all nations by training people going on medical missions trips to engage key people in the areas ministered to, giving people in the community information and key tools to bring about transformational change in their own communities. One significant component of this program is the annual International Wholistic Missions Conference, where the organization's staff conducts an in-depth seminar in the practices of CHE, with different workshops conducted for different levels of experience.

"Arizona Neighborhood Transformation" carries out an active Neighborhood Transformation ministry in the community of Guadalupe, Arizona, as well as supporting other programs around the Phoenix metropolitan area. The organizations core activity is the active running of a "learning lab" and tutoring center for students in Guadalupe.

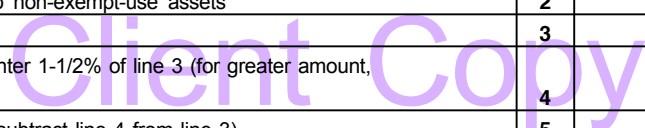
